#### What data do we collect and how do we use it?

# Who has access to your data?

- The BCC staff who deal with your enquiry. Other staff will have access to your data on a 'need to know' basis e.g. if we need to refer your enquiry to another member of staff to be able to answer it.
- BCC may disclose personal information if required to do so by law e.g. we are required to pass Gift Aid information to HMRC. BCC may also disclose information if

it believes that such action is necessary to protect our rights, property or safety and those of our students, staff, visitors or others.

• We will never share your data with Third Parties without your consent.

## Where is the data stored?

Information which you submit via our website is stored within the European Union.

## Your rights

Under the General Data Protection Regulation you have the following rights:

- To obtain access to, and copies of, the personal data that we hold about you;
- To require that we cease processing your personal data if the processing is causing you damage or distress;
- To require us not to send you marketing communications.
- To require us to correct the personal data we hold about you if it is incorrect;
- To require us to erase your personal data;
- To require us to restrict our data processing activities (and, where our processing is based on your consent, you may withdraw that consent, without affecting the lawfulness of our processing based on consent before its withdrawal);
- To receive from us the personal data we hold about you which you have provided to us, in a reasonable format specified by you, including for the purpose of you transmitting that personal data to another data controller;
- To object, on grounds relating to your particular situation, to any of our particular processing activities where you feel this has a disproportionate impact on your rights.

Please note that the above rights are not absolute, and we may be entitled to refuse requests where exceptions apply.
